Emissions are calculated and reported on a calendar basis (1 January – 31 December). No previous analysis has been conducted.</p> <p>The information provided below for the emissions of BHUK is only related to BHUK and not to any other company in the Besins Group.</p> <p>The scope does not currently include emissions from BHUK's medications that are manufactured outside the UK. We intend to quantify the emissions from our medications in the future.</p> <p>BHUK is committed to work with other affiliates within the Besins Group to identify and develop its carbon footprint reduction plan including carbon reduction targets in accordance with the company's commitment to support on delivering a net zero NHS.</p>

Carbon Reduction Projects

BHUK is committed to a carbon footprint reduction plan and reduction targets applicable across its activities.

Some activities have already been implemented including (but not limited to):

- Hybrid and flexible working offered to BHUK employees
- Encouraging use of public transport where possible
- Purchase of renewable electricity/energy by supplier with REGO certificate
- Improving energy efficiency by replacing incandescent bulbs with LED, sensors to turn off lights and using lower pre-set temperatures on heating
- Other environmental aspects (preferred sustainable suppliers, encouraging recycling in HQ office, remove single use items in the office)
